Students bringing guests to a MCS dance/event must abide by the following Code of Conduct:

1. MCS students must enter and leave with their guest. Once you have entered the dance/event, you may not leave and then return.
2. Guest must present student ID or driver's license for admission to the dance / event.
3. An approved guest application form must be on file with the school for admission to the dance/event.
4. Each application is verified for accuracy. In the event of any forged signature(s), both the MCS student and their guest will be denied admission.
5. MCS students are responsible for informing their guest of all MCS behavior and dress code rules all of which are available for review on the MCS website: www.maranathachristianschools.org
6. The following are specifically prohibited at school-sponsored dances: dance moves that are sexually explicit or which may result in disruption or injury (i.e., freaking, dirty dancing, slamming, moshing, etc.).
7. Any person removed from a dance/event by school supervision staff is NOT ENTITLED to a refund.
8. Middle-school students, regardless of age, are not permitted to attend an MCS dance/event.
9. Guests over 18 years of age may not attend any MCS dance/event. **(Exception: MCS Alumni with the Principal's approval)**
10. **One** guest per MCS student
