Students bringing guests to a MCS dance/event must abide by the following Code of Conduct:

1. Only one Guest per MCS student is allowed.
2. An approved guest application form must be on file with the school for admission to the dance/event. Please allow at least 48 hours for application review and approval prior to the event.
3. MCS students must enter and leave with their Guest. Once you both have entered the dance/event, you may not leave and then return – NO EXCEPTIONS ALLOWED.
4. Guest must present a student ID or driver's license for admission to the dance / event that matches the application information.
5. Each application is verified for accuracy. In the event of any forged signature(s), both the MCS student and their guest will be denied admission.
6. MCS students are responsible for informing their Guest of all MCS behavior and dress code rules all of which are available for review on the MCS website: www.maranathachristianschools.org.
7. The following are specifically prohibited at school-sponsored dances: dance moves that are sexually explicit or which may result in disruption or injury (i.e., freaking, dirty dancing, slamming, moshing, etc.).
8. Any person removed from a dance/event by school supervision staff is NOT ENTITLED to a refund. If removal of a Guest, then both the MCS Student and Guest will be removed.
9. Middle-school students, regardless of age, are not permitted to attend an MCS High School dance/event.
10. Guests over 18 years of age may not attend any MCS dance/event.
(Exception: MCS Alumni with the Principal's approval)
11. MCS may revoke Guest admission due to Covid conditions at any time.
12. If the guest tests positive anytime after 1 week of the event, it is the responsibility of the guest's guardians AND the MCS student's guardians to notify the Maranatha High School Principal immediately at pete.plotnik@gomcs1.com.
